Re: Records Access Request

We are replying to your request for information that was received on March 14, 2016. In that request, you sought access to the following:

1. Number of motor vehicle accidents involving cars registered to the car2go car-share service in Districts 1 and 2 of the City of Vancouver between January 1, 2013 and December 31, 2015;
2. Total number of motor vehicle accidents within the same area and time period;
3. Number of alcohol-related incidents involving vehicles registered to the car2go car-share service in Districts 1 and 2 of the City of Vancouver between January 1, 2013 and December 31, 2015; and
4. Total number of alcohol-related incidents within the same area and time period.

Attached please find the requested information.

These lists identify accidents and incidents involving vehicles owned by car2go. They in no way seek to identify car2go or the car2go member as being responsible for the accident or incident, and in no way place liability on car2go for any of the listed occurrences.

Information has been removed from this data pursuant to section 15(1)(a) and 22(1) of the *Freedom of Information and Protection of Privacy Act* ("the Act"). Excerpts of these provisions are attached for your ease of reference.

With respect to items 1) and 2) listed above, please note that police are not informed of all motor vehicle incidents. Please also note that police are only mandated to attend accidents involving injury. You may wish to contact ICBC for the number of motor vehicle collisions reported to that agency as they may collect more accurate data.

In response to item 3), please note that some locations and report dates may appear as duplicate entries. These numbers represent incidents that occurred at a police roadblock; each listed entry should be interpreted as an individual occurrence.

Under s. 52 of the Act, you may ask the Office of the Information and Privacy Commissioner to review our response to your request. You have thirty (30) days from the receipt of this letter to request a review by writing to:


