Re: Records Access Request

We are replying to your request for information that was received in our office on April 4, 2019. In that request, you sought access to a copy of the following:

- 1. The number of reported sexual assaults in Vancouver by neighbourhood and year from January 1, 2016 until January 1, 2019 inclusive.
- 2. The number of sexual assaults cleared for charge by the VPD in the same time period as #1.
- 3. The number of reports of sexual assault considered unfounded, unsubstantiated and founded by year for the same time period as #1.

We conducted our search using the following criteria:

- Stats Canada definition of sexual assault (please see page two of this letter);
- All offense method;
- Reported date (not date of occurrence); and
- All reported sexual assault (founded and unfounded).

Attached please find the responsive data.

Please be advised that the attached statistics represent a point in time. These numbers are dynamic and could change due to file conclusions and quality control.

You will notice that the number of founded incidents differs greatly from the number of recommended charges. It is important to note that there are several reasons a case could be coded as founded without charges. For example, it could still be under investigation (cases involving forensic analysis can take time), the accused could be unidentified, or it could be that there was not enough evidence to meet the Crown charge approval threshold. About 80 per cent of sexual assaults are groping incidents. Due to the nature of these offences, it is often difficult to obtain enough evidence to secure a charge.
