I write further to your request received by the VPD on June 23, 2015. In that letter you requested that the VPD compile and provide you with data related to sex assault investigations. You sought information for the years 2010,2011,2012,2013, and 2014.

The VPD has allocated considerable resources in order to make every reasonable effort to satisfy your request. Attached please find a table, prepared by a VPD Sex Crimes Unit Analyst, that provides you with compiled data that is responsive to your request.

Please note that the attached table satisfies your queries at 1,2,3.

With respect to query 4, accurate court disposition data is maintained by the courts in a court database that is not in the custody or control of the VPD. The VPD is not in a position to provide you with accurate conviction information as this data is not within the custody or control of the VPD.

With respect to query 5, this information is not recorded by the VPD and is therefore not included in the table.

With respect to query 6, this information is not available in a form that can be reasonably compiled. The VPD has, to date, allocated approximately 8-10 resource hours to your request. While it is our position that *the Freedom of Information and Protection of Privacy Act* does not require the VPD to manually compile the data you have requested, in the event that this position is not upheld, the VPD would be required to levy a fee estimate of between 35-50 hours to fulfil this portion of your request.

With respect to your request for data that VPD provided to Statistics Canada, that data is available and can be downloaded in multiple formats via the following public link:
