We are replying to your request for information that was received on November 8, 2021. In that request, you sought access to information related to a call at the Shell station at 3596 W 41st Avenue on November 6th 2021 for a medical incident. Upon review of our records we identified VPD file no. 21-185606 as responsive to your request.

Enclosed please find a copy of the requested records.

Information that could unreasonably invade the privacy of other persons has been removed from the police reports. Particular emphasis in this case has been placed on section 22(3)(b) of the *Freedom of Information and Protection of Privacy Act* ("the Act"). An excerpt of this provision is attached.




