Course Objectives

The goals of Crisis Intervention Training (CIT) are to:

- Initiate proactive intervention to deter crises which might involve high levels of force
- Minimize the use of force by police officers dealing with the mentally ill or citizens in crisis
- Reduce in risk & injuries to police officers
- Reduce liability through improved crisis management
- Facilitate identification & tracking of individuals through Mental Health Emergency Services who either exhibit chronic behaviours that pose a risk to themselves or others &/or place a significant drain on police resources
- Develop a stronger partnership between police, the mental health community, & the community as a whole
- Increase public confidence & support with police intervention.

Learning Objectives

By the end of the course participants will be able to:

- ✓ Identify most common apparent mental disorders & psychiatric illnesses, such as:
 - general concept of mental illness
 - early psychosis
 - bipolar disorder
 - schizophrenia
 - drug psychosis
 - · age-related mental illnesses
 - FASD
- ✓ Apply the basic tools to assess behaviors & risk associated with these illnesses
- Recall services available in Vancouver for this clientele & how to access these services
- ✓ Distinguish tactical considerations for police officers when dealing with people in crisis

- Explain the effects of critical incidents on the officers, on Post-Traumatic Stress Disorder & the importance of officer's self-care
