I am writing to express gratitude for the tireless work the Vancouver Police Department has undertaken over the last 16 months to protect & serve Vancouver in response to the demands of COVID.

Watching news unfold as everyone tries to respond to these demands - and the added pressure arising from funding conversations regarding police - we recognized that police could use additional support to develop a more coordinated, transparent and effective social response.

The Edmonton Police Service recently had us perform a Social Impact Audit ("Money In the System"), which identified approximately \$7.5 billion in investments made annually to social

support and community services in the City of Edmonton. A detailed presentation of the findings is included here for your review: <u>Social Impact Audit Presentation</u>

It is a compelling case for why now we have the perfect opportunity to recalibrate our social safety net.

We are undertaking a similar effort at a National level, and are putting together a cohort of interested Police Services, to influence broader conversations around spending on social issues that will help relieve some pressure off of Police departments.





Hello again,

Thank you all for your transparency today around needing to have something in hand by October 15th and about not wanting to compromise the quality of the data in the SIA Report.

Upon further discussion with our team, we propose maintaining the current timeline but adding a Snapshot Meeting for mid-October.

Supporting this overall timeline ensures that we can keep the entity-level data as detailed as we had first intended, but still gets VPD something to start considering in terms of a high level picture.

Specifically, we would be able to answer the following research questions at 6 weeks for mid-October:

Core How much money is allocated to health, protective services, charities, non-charities, individuals and other community social services in the community? - Data discussion:
 - o Current scope doesn't include KPI measures or outcomes
 - Police budget numbers for the SIA don't include capital expenses
 - Flow through costs for charities aren't included
- Data requests, if necessary, should be directed through Drazen who will then coordinate with Simon & team for processing
 - Any additional budget details from other agencies will be requested through VPD (best practices in other jurisdictions suggests this is usually most effective at a Chief to Executive relationship level making the request)
- VPD has a dedicated Mental Health Unit of 8 officers
 - Primary focus is to identify individuals who repeatedly require police intervention who would benefit from being connected to support services
- Would specifically like to look at downtown East Side in terms of services and funding going
 into the area this is an option that HelpSeeker will be able to look at after the initial data
 analysis and will find out more details from data team on this
- End use of SIA is as a tool to efficiently and effectively engage with community partners
 - These allies and partnerships are yet to be identified
- The SIA will also support discussions with the Special Committee on Reforming the Police Act - big reform expected Spring 2022

- On July 8, 2020, the Legislative Assembly appointed the Special Committee on Reforming the Police Act to examine, inquire into, and make recommendations to the Legislative Assembly on: reforms related to the modernization and sustainability of policing under the Police Act (R.S.B.C. 1996, c.367); the role of police with respect to complex social issues including mental health and wellness, addictions and harm reduction; the scope of systemic racism within BC's police agencies; and whether there are measures necessary to ensure a modernized Police Act is consistent with the United Nations Declaration on the Rights of Indigenous Peoples (2007).


INTRODUCTION


