VANCOUVER INCEST AND SEXUAL ABUSE CENTRE (VISAC) 604-731-4951

This centre offers support and information to children and youth who have been sexually or physcially abused, and to their non-offending family members. Also works with children and youth witnesses of crime and provides information and support to adult survivors of child sexual or physical abuse.

Services include information and explanation of the court system, court orientation, accompaniment to court and other interviews, case progress information, crisis intervention and ongoing emotional support, assistance in completing the Criminal Victim Assistance Progrm forms and victim impact statements, and referrals to other services.

RESIDENTIAL HISTORICAL ABUSE PROGRAM (RHAP) 604-875-4255

RHAP funds professional counselling for adults who were sexually abused as children while living in a provincially funded residence.

MOSAIC's Multicultural Victim Services provides emotional support, information about your rights, and referrals for those living in Vancouver and Burnaby. The program serves the specific needs of multicultural and immigrant peoples. Support is available in English and Vietnamese. MOSAIC Multicultural Victim Services can:

- Provide resources to deal with trauma
- Create action and safety plans
- Provide information on abuse and crime, legal, housing, healthcare, and mental health options

WHAT IS SEXUAL ASSAULT?

Sexual assault includes any form of sexual contact without a person's consent, including the threat of sexual contact without consent.

Victims experience a range of emotions, including fear, self-blame, anger, shame, sadness, depression, confusion, numbness, grief, and denial. A sense of violation, powerlessness, and loss of trust may also be experienced.

Emotional distress can have a physical impact as well, resulting in symptoms such as gastrointestinal issues, headaches, and changes in sleeping and eating habits. Emotional support from others is important to the healing process.

VICTIMS' RIGHTS

- The right to request information about the justice system and their case
- A right to have their secruity, privacy, and views considered
- Victim Services can assist victims with understanding and exercising their rights
- Victims will be given specific information about the process for accessing victim services in their jurisdiction
- To have information on how to register for the victim notification service

Victim services is accessible to anyone in need, whether or not they have reported the crime to police. There are no fees to access any of Family Services of Greater Vancouver Victim Services.

BC WOMEN'S HOSPITAL & HEALTH CENTRE SEXUAL ASSAULT SERVICE

If a sexual assault happened within the past seven days, a victim can go directly to Vancouver General Hospital's Emergency Department (open 24 hours) at 920 West 10th Avenue or to UBC Hospital Emergency Department Koerner Pavilion at 2211 Westbrook Mall (open 8 a.m. to 10 p.m.). A team of examiners are on-call 24/7/365.

The following confidential services are provided:

- Assessment and treatment of injuries and sexually transmitted infections
- Drug and alcohol screening tests
- · Information and legal options
- Forensic sample collection if the victim decides to involve police
- Medical report for police
- Referrals to health, legal, and community-based support services

SALAL SEXUAL VIOLENCE SUPPORT CENTRE

Salal's community-based victim services program supports women, trans, non-binary, Two-Spirit, and gender diverse people, navigating medical care and understanding systems of accountability after a sexual assault.

They are trained to provide justice system information, support, liaison with justice system personnel, and court accompaniment to male survivors who wish to explore avenues of justice.

CRIME VICTIM ASSISTANCE PROGRAM 604-660-3888

Crime Victim Assistance Program assists victims, immedate family members, and some witnesses in coping with the effects of violent crime. It provides financial benefits to help offset financial losses and assist in recovery. Benefits include counselling. For sexual offences, the crime must have occurred after July 1, 1972.
