In that request, you sought access to “a detailed and itemized list of all costs (in Canadian dollars) associated with the February 2024 visit to Canada by Prince Harry, Duke of Sussex, and his wife Meghan, Duchess of Sussex (aka Meghan Markle). Such costs could include (but are not exclusive to) security, transportation, accommodation, meals, overtime, per diems, uniforms, dry cleaning, decorations, gifts, venue fees, planning costs, honorariums, vehicle rentals, printed material, etc. Please also provide a total cost associated with this trip”.

The VPD Finance Section compiled the following information based on police overtime costs for this February 2024 visit. The other itemized information you suggested cannot be accurately calculated or compiled.

Since our reply the VPD Finance Section has provided the following updated police overtime costs for this February 2024 visit.

Description	Amount
Cost recovery	(\$10,221)
Overtime for police security	\$44,555
Total Cost to VPD	\$34,333

The overtime calculated for police security of this event is \$44,555. This amount was offset by \$10,221 by cost recovery from Invictus Games Vancouver Whistler.

The total number of hours worked is 390.50 hours.
